


## GAT's Ninth Annual Picnic Begins Tenth Anniversary Celebration

"This is the first picnic we ever attended and Tommy really had an excellent time." This statement by one of the mothers following the Tenth Anniversary Family Day Celebration at Camden Amusement Park, August 25, just about summed up the family viewpoint toward the day's activities.

Approximately 7,200 persons attended the Ninth Annual Company Picnic which kicked-off the Tenth Anniversary Celebration, September

1962 marks ten years since the announcement that The Goodyear Tire & Rubber Company had been selected to operate the AEC's newest and largest gaseous diffusion plant.

The Park was reserved for Goodyear Atomic employees and their families from 12 noon until 4 p. m. At approximately 10:30 a. m., Goodyear families began filling the Park. By the time the rides were in operation, at noon, a steady line of GAT boys and girls began enjoying each of the rides. Many employees

brought a basket dinner and participated in a family outing on the picnic grounds inside the Park.

The planning of the Tenth Anniversary Committee and Picnic Committee; the cooperation of The Goodyear Tire & Rubber Company's personnel; the Exhibit Managers of the AEC's American Museum of Atomic Science; and Camden Park's management was excellent. The addition of the large number of gifts made possible by The Goodyear Tire & Rubber Company added much to the employee interest in the celebration.

Also, GT&R's Product Exhibit and the AEC Exhibit, "This Atomic World", drew large crowds.

A near continuous line of employees strolled past the exhibit area to view the various exhibits and receive the colored aerial photograph of the plant, Tenth Anniversary brochure, and tire ashtray with the GAT Tenth Anniversary medallion, as mementos.

The GT&R Exhibit called the at-

Beginning at noon and every fifteen minutes thereafter until 2:30 p. m., the names of the employees who were winners of Tenth Anniversary prizes were announced. At 2:30 p. m., R. M. Rutherford, manager, production division, assisted by Max Warnock, cascade maintenance department, began the drawing of the picnic prizes. ## Employees Establish Gaseous Diffusion Plant Safety Record

"When a professional athletic team is defeated by an opponent, the set back is analyzed and strategy is planned which they hope will bring victory the next time they meet. We have a well-balanced team of seasoned competitors who have shown they have the desire to win."

G. H. Reynolds, general manager, made the above statement recently concerning GAT's latest manhour safety record.

The statement bears repeating at this time because of the disabling injury which occurred on August 24, 1962. As of August 25, 1962, Goodyear Atomic's current safety record returned to ZERO.


Our employees still recognize that safety is an integral part of the work program and that a failure or disappointment means that greater determination and greater desire to fulfill the safety program is necessary.

The latest safety record by the employees of this plant stands at approximately 7,968,967 manhours. This is a record that took two years, two months, and 16 days to achieve.

We now have the challenge to beat our own record which earned this plant the title — THE SAFEST PLANT IN WORLD-WIDE GOODYEAR.

The disabling injury happened at 2:45 p. m., August 24, 1962. The injured employee was doing routine electrical maintenance work on an

## "Unto the least of these . . ."

Last Sunday the churches of America offered their greetings to the labor movement of this country, affirming their common concern for the aspirations, needs, and responsibilities of those both within and without their memberships who either work or seek work.

Church and Labor do well to remember with penitence the words of One who says, "Inasmuch as ye did it not to one of the least of these, ye did it not to me." The measure of a society lies not in what it does for the affluent and strong, but in what it makes possible for the poorest and weakest of its members. It is judged by what it does to prevent poverty, injustice, and needless suffering.

The resources in which our land abounds, inventive and technical skill, efficient management, the influence of organized labor, democratically forged institutions and public policies — all these have combined to produce unprecedented plenty. This must be said not boastfully but in humble recognition of our common stewardship. It is estimated that within the last two decades, the American economy reached the point where it can produce sufficient goods and services to do away with poverty in our land.

At the same time many persons in other lands do not have access to the abundance which we enjoy. This is conspicuously true among less favored peoples, whose knowledge of our affluence adds bitterness to their want. Both the churches and the organizations of labor have urged that the United States should be bolder in sharing its resources with those of other countries in programs of world economic development.

All segments of our American community—the church and the labor movement no less than government, industry, and agriculture—share a grave responsibility for the underprivileged, the "least of these" whom Christ regards as brethren. Both the churches and the organized labor movement must acknowledge that we have been far more effective in serving the interests of the relatively secure than in coming to grips with the problems of these most exposed, vulnerable and disadvantaged groups.

The church through the years has extended its ministries to the weak and unfortunate. The labor movement, grounded in a tradition of mutual aid, has made significant contributions in this regard. Government likewise has had an important role in implementing the community's concern.

Today, when for the first time in human history it is possible to do so, let us work together in an all-out effort to abolish poverty both at home and abroad. Poverty is no longer necessary; it is ethically intolerable. This is the opportunity and responsibility God has put into our hands. We dare not refuse or postpone our response.

auxiliary panel in the X-326 building. A breaker was grounded causing an electric arc. This arc resulted in severe electric arc burns to both eyes.

The injury is classified, at present, as a temporary total disabling injury in accordance with American Standards Association (ASA) Code Z16.1-1954.

The injured employee, upon the advice of the GAT physician, was taken to Grant Hospital in Columbus. He remains under the care of an eye specialist.


## Interleague Golf Match
