Second Core Loading

GAT Supplies Hallam Reactor

Goodyear Atomic Corporation has made the initial withdrawal of 4.9 percent assay product to supply the second core loading for the Hallam Reactor in Hallam, Nebraska.

The Hallam Nuclear Power facility is a sodium-graphite reactor built under the AEC's Power Demonstration Reactor Program (PDRP).

The Hallam Reactor, which is operated by the Consumers' Public Power District, went critical in 1962, and produces a net 75,000 kilowatts.

The total product requirements for the reactor's second core, when completed, will represent approximately \$17.9 million.

The Hallam Reactor was built for the AEC by Atomics International, Division of North American Aviation, Canoga Park, California.

The Sodium-Graphite Reactor concept began nearly two decades ago by Atomics International.

The sodium system's high temperature operation and high thermal efficiency support the prospect for lower power costs in the near future. It is also the logical next step for later transition to fast breeder reactors which promise even lower power costs.

"The Company, in a sense, is a citizen of the various communities surrounding the plantsite," stated Bliss. "Therefore, management feels that it is our civic duty to lend support in every way possible to the United Fund program which is designed to better health, welfare and character-building conditions within each community. The Company also feels that by providing its employees the opportunity for fulfilling their obligation to the needy in their communities, through 'organized giving' just once a year, the employees are relieved of the annoyance of a multiplicity of solicitations throughout the year."

Goodyear, as a Company, has always supported the United Way. When Goodyear Atomic Corporation was established in Southern Ohio, the management felt that the Company, and its employees wanted to lend support to the health and welfare agencies in the area. Last year the average gift, per employee, was approximately \$12 per contributor. Nearly 9 out of 10 employees (88%) participated. Five out of 10 (52.9%) of the participants gave through payroll deduction.

Recommend Payroll Deduction

The All-In-One Campaign has never set a monetary goal. Annually, the effort seeks 100% participation by the employees. This year it is hoped that the average contribution will be increased and that the number of employees using the payroll deduction method also will be increased. The payroll deduction method is the recommended method of pledging a contribution. It is suggested that a fair share contribution is — one hour's pay a month.

Students Should Prepare For Annual Scholarship Tests

Goodyear employees, who have sons or daughters as juniors in high school, are reminded that the National Merit Scholarship examination will be given either March 10, or March 14, 1964. An alternate date may be selected at the option of the high school principal.

This examination is a "must" for Goodyear students if they desire to qualify for a four-year college scholarship under The Paul W. Litchfield Merit Scholarship Program. Students should check with their high school principal for the test date at their high school.

To be eligible, one of the parents of a Goodyear son or daughter must have at least two years of continuous service with Goodyear or any of its subsidiaries.

Children of retired or deceased employees who had worked with at least two years' continuous service are also eligible.

A Litchfield Merit Scholar is selected on the basis of scholastic aptitude, leadership and good citizenship as determined by the nationwide NMSC competition.

The qualifying examination in March, 1964, determines whether a student becomes a semi-finalist in NMSC competition and eligible for the examination to be given the student's senior year.

The National Merit Scholarship Corporation was established through a \$20 million grant from the Ford Foundation and \$500,000 grant from the Carnegie Corporation of New York. The initial Ford Foundation grant was for the period 1955-65. The new grant will cover the years to 1970.

In the first year of the Merit Program business corporations and similar organizations were invited to participate as sponsors of Merit Scholarships. The number of sponsors has increased from twenty-four in 1956 to more than 150 in 1962. Support for NMSC's research has come from an additional Carnegie Corporation grant, grants from the Old Dominion Foundation, and the National Science Foundation.

In 1962, Mrs. Paul W. Litchfield and her two daughters in honor of the late Goodyear executive, established four, four-year undergraduate scholarships to be awarded to children of Goodyear employees anywhere in the United States to enable them to obtain an education at the college or university of their choice. One scholarship will be awarded each year.

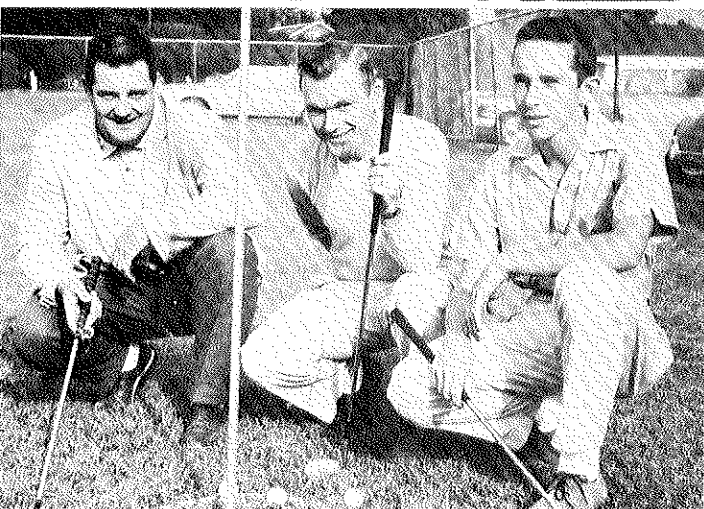
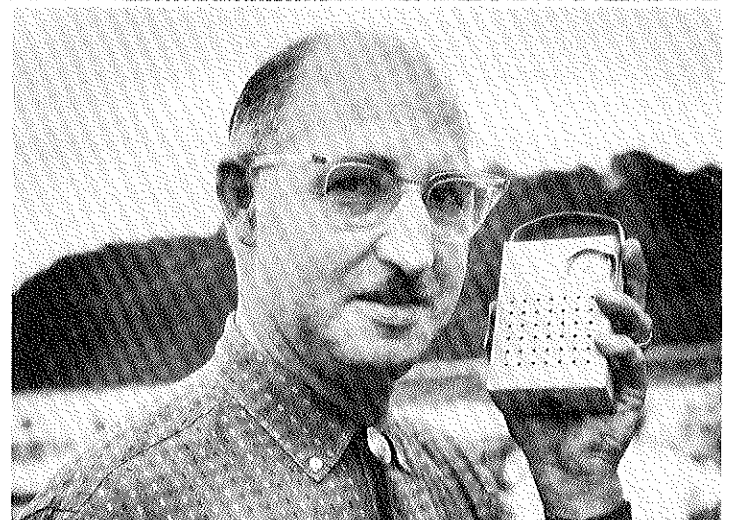

AEC Extends Contract

Union Carbide's operating contract has been extended, by the AEC, until June 30, 1967.

Union Carbide operates four major AEC facilities — two production facilities and the National Laboratory in Oak Ridge, Tenn., and the gaseous diffusion plant at Paducah, Kentucky.

Under the contract, the Commission provides the working capital and the cost of operation and pays Union Carbide a fixed annual fee.

Nuclear Exhibit

Dr. Glenn T. Seaborg, Chairman of the Atomic Energy Commission, participated last Saturday, in ceremonies officially opening the U. S. "Atoms at Work" exhibit of the peaceful uses of atomic energy in Belgrade, Yugoslavia.

The exhibit, which covers a wide range of the peaceful applications of atomic energy, was presented jointly by the USAEC and Yugoslavia.

"Atoms at Work" was redesigned before its showing in Vienna last spring, and a number of new features have been added. Previously it had been displayed in Cairo, Egypt, and Lahore, Pakistan, in 1960; in Beirut, Lebanon, in 1961, and in Athens, Greece, and Bangkok, Thailand, in 1962.

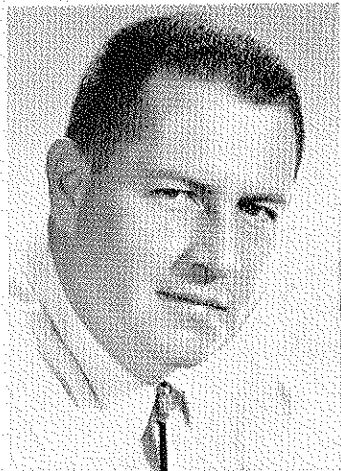
While the exhibit will give the general public an understanding of the many uses of atomic energy in everyday life, it also will serve as a laboratory for experiments of interest to Yugoslav scientists and as a training institute for hundreds of college and high school science teachers and students.

Receives AEC Citation

Dr. Shields Warren, for many years one of this country's leading authorities on atomic radiation, has been named to receive the Atomic Energy Commission Citation.

Dr. Warren is Scientific Director of the New England Deaconess Hospital's Cancer Research Institute, Boston, and professor of pathology at Harvard University. He will receive the AEC citation because of his outstanding service as U. S. Representative to the United Nations Scientific Committee on the Effects of Atomic Radiation.

The Atomic Energy Commission Citation was established for presentation to persons, not in the employ of the commission, who have made meritorious contribution to the nuclear energy program.

Crawford Transfers To Chem. Operations In Production Move

This Friday, September 27, 1963, J. G. (Jack) Crawford, assumes the responsibilities as supervisor of the chemical operations department. R. M. Rutherford, manager, production division, made the announcement earlier this month.

'Round The World

Topeka, Kansas

Goodyear will construct a new multi-million dollar warehouse and distribution center in Topeka, Kan.

President Russell DeYoung stated that the new facility, which will handle tires produced by plants in several cities as well as other Goodyear products, will replace rented warehouse space in Kansas City and elsewhere.

Hugh Porter, GAT's first superintendent of electrical and instrument maintenance, is now manager of engineering at Goodyear Topeka.

Construction of the new center, which will have approximately 600,000 square feet of floor space, will begin this fall with completion due by mid-1964. The center will be erected on Goodyear-owned property adjacent to the Goodyear Topeka tire plant.

Goodyear Aerospace

Goodyear Aerospace Corporation in Akron has been awarded a contract for a feasibility study and preliminary design of a saucer-shaped communication test satellite.

Ordered by the National Aeronautics and Space Administration's Langley Research Center, Hampton, Va., the 50-foot diameter model could be used to discover how effectively a new type of orientation system improves the capability of passive communication satellite systems.

The "Gravity gradient" system utilizes the gravitation pull from the earth and moon so that the larger reflective portion of the satellite would always be pointed toward the earth.

The structure will resemble the typical idea of a "flying saucer," except for two 40-foot-long tripods extending from each side. A weight at the end of each tripod will orient the satellite in its earthward position.

Goodyear Addition

A plan for acquisition of the business and assets of Motor Wheel Corp., Lansing, Mich., by Goodyear has been approved by the managements of both companies.

In the proposed acquisition, Goodyear will issue shares of its common stock for the assets of Motor Wheel, on the basis of two Goodyear shares for three shares of Motor Wheel.

The transaction is subject to approval by directors of both companies and Motor Wheel stockholders.

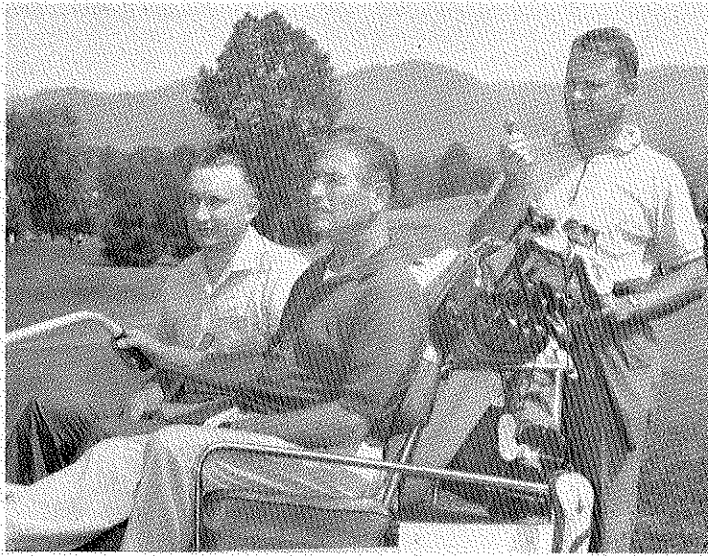
Goodyear Board Chairman E. J. Thomas said Motor Wheel will be operated as a major Goodyear subsidiary. No management or personnel changes are contemplated.

Motor Wheel is a manufacturer of wheels, for autos, trucks, buses, and farm equipment, hubs and brake drums for automobiles and trucks, and heaters and undercarriages for mobile homes.

Thomas said the acquisition would complement Goodyear's existing product lines. These include tires of all kinds, and rims for trucks, buses, and earthmoving equipment. He pointed out this diversification into a new but related area of transportation products will enable Goodyear to offer a more complete line and serve its customers effectively.

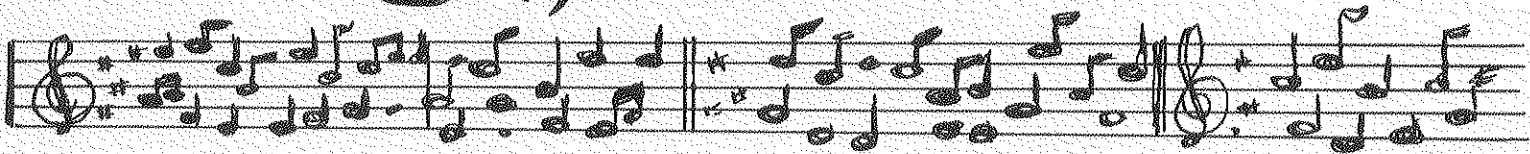
