GT&R Sets All Time High Records In Sales And Income

The Goodyear Tire and Rubber Company recently released two reports containing a synopsis of 1968 activities. — The 1968 Annual Report to Shareholders and 1968 Report to Employes.

Russell De Young, Chairman of Board, and Victor Holt, President, quoted interesting information in the reports. Portions of their statements are reprinted for the benefit of Clan readers.

Copies of 1968 Report to Employes was mailed to each employe's ! me. (Extra copies are available from Community Relations.)

Consolidated Financial Statements of the Company for the year 1968 reflected continued growth to record levels of sales and income.

Consolidated Net Sales of \$2,925,744,887 compared with \$2,637,709,500 in 1967. The growth of \$288,035,387 over last year's record sales represents a gain of 10.9%.

Consolidated Net Income of \$148,262,340 or \$4.12 per share of common stock compared with 1967 per income of \$127,065,887 or \$5.54 per share. The increase of \$21,196,453 was equivalent to a 16.7% improvement over the previous income record established in 1967.

Dividends of \$1,425 per share vere paid in 1968 compared with \$1,35 per share in 1967. Total dividend payment amounted to \$50,924,823 in 1968 and \$48,106,998 in 1967. In the third quarter of 1968 the annual dividend rate was increased to \$1.50 from the \$1.35

rate established in 1966.

Earnings of foreign subsidiaries for 1968 amounted to \$38,767,844, compared to \$36,155,906 in 1967. Foreign earnings reached a new record despite the adverse effects of a prolonged strike at New Toronto, Ontario.

The new all-time records for sales and net income reflected our Company's ability to capitalize on the increased demand for tires and other products our Company makes for public, industrial and govern-

Split Declared

Sharsholders of Goodyear have cleared the way for a planned two-for-one split of the company's stock.

They did so by approving an amendment to the articles of incorporation increasing the number of authorized common shares from 50-million to 100-million. The amendment also eliminated shareholder's pre-emptive rights.

Goodyear's directors voted the stock split eight weeks ago, subject to favorable shareholder reaction on the share increase.

mental consumption. Significant advances were made in research; important new product lines contributed to record sales.

The record capital expenditures were for plant facilities both in the United States and throughout the world. In addition to new plants, our Company invested heavily in the expansion and modernization of existing facilities to meet the demands of expanding markets and to prepare for future needs.

Early this year, Goodyear went into volume production on its Polyglas tire, a new type of tire built on a new concept in tire construction. The Polyglas tire features a biasply polyester cord body and fiberglass belts under the tread.

Not since the introduction of the tubeless tire has the public been presented with such an exciting new tire innovation.

Introduction of the new Polyglas tire marks the second time in recent years that Goodyear has paced the nation's tire makers in the development of a new and successful tire.

Jackson Aerospace Renamed Commercial Plastics Division

The Goodyear Aerospace Corporation Jackson, Ohio Plant has been renamed its Commercial Plastics Division to more properly identify its products and purposes, Morris B. Jobe, president, recently announced.

The \$2-million, 78,000-square foot plant produces fiberglass-reinforced polyester components and products for the automotive, small machinery and other industries. Since its opening in June 1966, it has been called the Jackson Division.

Current products include an air deflector for the rear windows of a 1969 model station wagon, single-piece hood and fender units for a heavy-duty truck, bodies for lawn-mowers, garden tractors and skimobiles, tractor fenders and instrument panels.

The Jackson Plant and the United Workers Local 820 also recently announced the signing of a new three-year contract. John F. Lombardy, plant manager, and United Workers of Local 820 stated that the new contract provides the union with increases required for our growing standard of Jiving while seeking a stable labor relationship and improved working environment. Both union and management committees displayed a cooperative attitude through the negotiations.







The first major breakthrough was the development of polyester as a revolutionary new tire cord material.

The Company's General Products Division continued to record successful gains during the year, and there is great potential for future growth.

The general products list includes instrument safety panels and foam cushioning for autos; rubber blades for snowplows; wheels, hubs and brake drums for cars and trucks; airplane wheels and brakes; hose; transmission and conveyor belts of all types; center wing sections for the jumbo jets; aircraft canopies and windows; rubber railroad crossings; flooring for home and commercial use; packaging film and plastic sheeting; shoe products, and chemicals for hundreds of uses.

Our subsidiary, Goodyear Aerospace Corporation, a major prime contractor and subcontractor to the defense and aerospace industries, again made advances in wildly diversified areas.

Goodyear achieved new records in both sales and profits in foreign markets in line with the accelerating international demand for tires and other rubber products.
