## ES&H review slated for summer

Safety and environmental functions and facilities at the Portsmouth Gaseous Diffusion Plant and Goodyear Atomic Corporation's operational procedures will be the subject of two important U.S. Department of Energy Headquarters appraisals over the next several months.

Prior to that time, considerable planning and preparation will be conducted toward successful completion of the appraisals.

The appraisals are part of U.S. Department of Energy Secretary John S. Herrington's environmental and health initiatives which are being coordinated for all DOE facilities by Assistant Secretary of Energy Mary L. Walker.

The first appraisal — the DOE "Environmental Survey" — is the initial phase of the long-range strategy, covering about two and one-half years, to identify, assess, prioritize and correct environmental and safety concerns at all DOE facilities. The Portsmouth plant environmental survey is scheduled for August.

The second appraisal — the DOE "Technical Safety Appraisal" — is scheduled for the Portsmouth plant in October. This multi-disciplined appraisal has as its objective an assess-

ment of DOE-wide consistency in the application of safety requirements at all of its nuclear facilities.

Both appraisals will include a review of Goodyear Atomic operations at all levels and an examination of site equipment and facilities.

The assistance and support of each employee is necessary to successfully present GAT's ongoing commitment to a safe workplace and a clean environment for employees and GAT neighbors alike.

It is requested that each Goodyear Atomic employees extend all courtesies to appraisers visiting their work areas by providing all requested information with regard to job functions and their relationship to overall plant uranium enrichment programs.

Favorable appraisal ratings of GAT's facilities, personnel and operating practices are important to each of us. Goodyear Atomic continues to support DOE by providing high quality, cost effective and "on-schedule" product deliveries while providing employees with a safe work environment.

The continued support of all GAT employees can and will result in favorable audit results and will also be reflective of the high professionalism of the Goodyear Atomic workforce.

## Registrations total 242 at third business fair

To identify new sources of supply and increase the volume of business being done with present suppliers to the U.S. Department of Energy's (DOE) Portsmouth Uranium Enrichment Plant, Goodyear Atomic Corporation completed a "Business Opportunity Fair" May 14 at the Sheraton Columbus Plaza.

Potential suppliers of industrial equipment, supplies and services to the plant were invited to attend. Special emphasis was directed toward expanding the volume of business being done with Small, Small Disadvantaged and Woman-Owned businesses.

Other companies and organizations in addition to Goodyear Atomic had booths at the fair, with representatives available to discuss purchasing needs of their specific organizations. These agencies and businesses include the U.S. Department of Energy's Oak Ridge Operations Office and Portsmouth Enriching Office, The Goodyear Tire & Rubber Company and several of its Ohio plants, Goodyear Aerospace Corporation, RMI Company, Westinghouse Materials Company of Ohio, the U.S. Small Business Administration and the Columbus Regional Minority Development Council, Inc.

These agencies conducted similar business opportunity fairs in Columbus and Cincinnati in February 1985.

RMI Company and Westinghouse Materials Company of Ohio are operating contractors of other Department of Energy facilities in Ohio.

## Income tax laws vary city to city

Many Goodyear Atomic employees live in cities which have city income tax laws.

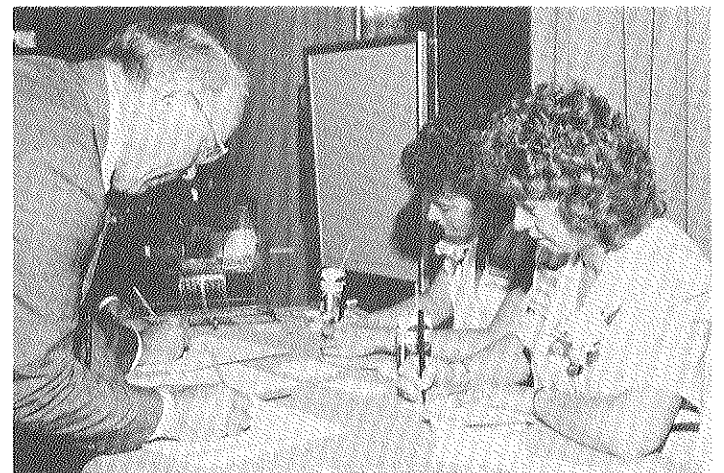
Goodyear Atomic does not withhold city income taxes or report the amount of taxable wages for city tax purposes on the W-2 form.

The definition of "taxable" wages may vary according to the individual city's tax law.

Many cities, like Chillicothe and Portsmouth, define "taxable wages" to include amounts put aside in employee savings plans, though Federal and Ohio income tax laws exclude those amounts.

It is important that each employee understand his or her city income tax coverage and file returns accordingly.

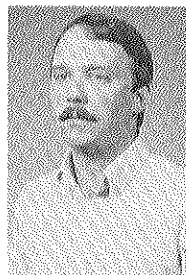

## BIHL

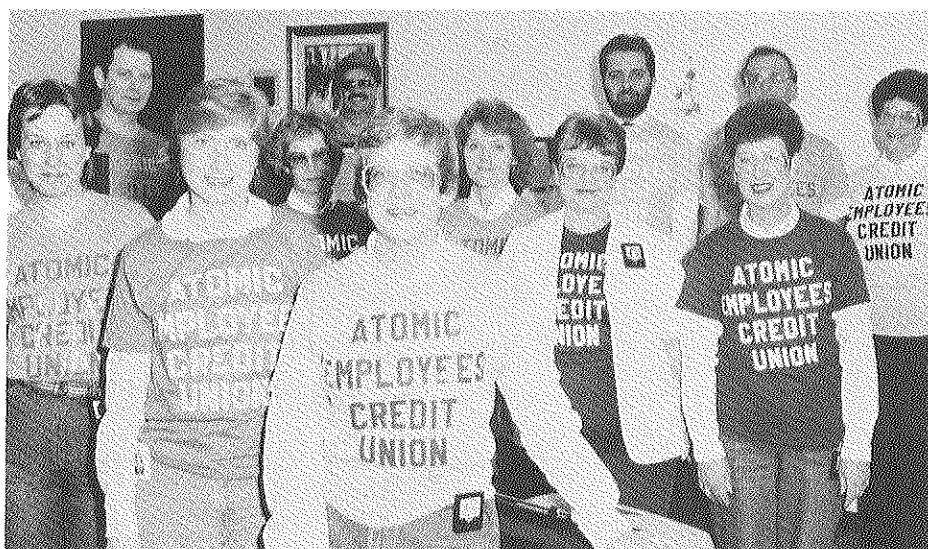
