

service during the construction of the Portsmouth Area plant, Peter Kiewit Sons' Co. conducts a special 40-hour training course

for all new Guard Force person-

The course, which covers over a dozen different subjects peculiar to the type of operation being carried on here, is completed by all guards regardless of previous experience.

The program is under the direction of Educational Training Officer Lt. J. R. Fite. Included in the 40-hour training period are both classroom and firing range instruction. Lt. Fite is as-

Major courses covered during the training period include: Security, Guard Force Organization and Operation, Records and Reports, Badges and Passes, Laws of Arrest and Detention, First Aid, Traffic Operation and ontrol, Plant Geography, Pubtic and Employee Relations, Pistol and Rifle Shooting and Fire Fighting and Prevention.

Special instruction in Fire Fighting and Prevention is supplied by PKS Fire Department personnel.

Force applicants must measure up to various qualifications set up by the company and be able to obtain security clearance from the Atomic Energy Com-

PKS Transfers First Permanent Buildings To Goodyear Atomic

With the construction phase of the U.S. Atomic Energy Commission's Portsmouth Area gaseous diffusion plant well under way, the first group in a series of permanent buildings has been turned over to the operating company by the prime contractor, Peter Kiewit Sons'

It has been announced by PKS General Manager George C. Holling that nine permanent structures or portions thereof have been transferred to the Goodyear Atomic Corporation to date. GAT will operate the The PKS Safety Department | multi-million dollar installation for the commission upon completion.

Goodyear Atomic has taken over complete operation of the project's X-540 General Telephone Building, X-620 Nitrogen facility, X-615 Sewage Plant, X-104 Guard Headquarters, X-103 Operations Control Headquarters, X-760 Chemical Engineering Building and X-750 Mobile Equipment Maintenance and Stores Building.

REFAREA WORKERS DVER MEMORIAL DAY

The near record of traffic fatalities registered throughout the nation over the long 1954 Memorial Day weekend took its toll of Portsmouth Area project employees travelling the highways.

Three project employees, all Grinnell Corporation personnel, died as a result of traffic mishaps on Saturday, May 29. The three deaths brought the total of area workers killed in traffic accidents to 15 since January 1, 1953.

The three Memorial Day fatalities were the sixth, seventh and eighth chalked up against Grinnell Corporation employees since December 27 of last year. The ironic touch to this story is Grinnell's outstanding on-site safety record. The company recently was presented with the National Safety Council's highest award for completing over three million man-hours of construction without sustaining a lost-time accident.

Killed in the two Memorial Day mishaps were: John Judd, Jr., 40, of Lakewood, Ohio; Andrew P. Kane, 59, of Euclid, Ohio and Donald W. Sutter, 35, of Pryor, Oklahoma. Judd and Kane were residing in Waverly and Sutter on Route 124 near Piketon, while employed on the project.

Judd and Kane were killed in a one-car accident on Ohio Route 3 approximately 10 miles north of Wooster early Saturday morning. Both men were dead on arrival at Lodi Community Hospital at Lodi, Ohio. Injured in the crash were Robert Bentlinger and John Chambers. Bentlinger was treated and released and Chambers' condition was reported as good by hospital attendants.

Sutter was reported killed instantly when his car left the road near Dawson Springs, Kenucky, also early Saturday morn ing. Sutter was reported to have been alone enroute to LaCenter, Kentucky for the weekend.

Planning, Scheduling And Control Dept. **Marks Job Progress**

An integral part of the operation of the office of the General Manager of Peter Kiewit Sons' Co. on the Portsmouth Area project is the Planning, Scheduling and Control Depart-

This department, headed by C. T. Fingland, is composed of Planning and Scheduling, Procurement Control and Progress Control Divisions.

The Planning, Scheduling and Control Department is responsible for providing the direction required for procurement of information required from Architect Engineers, and also for the procurement of permanent construction materials and equip-

The department also supplies the direction necessary for construction operations of fixed price subcontracts and cost type work done by prime contractors and subcontractors.

The phasing of all activities which control procurement and construction operations and the recording and analyzing of procurement information are additional important functions of the department's operation.

The Planning, Scheduling and Control Department records daily the comparison between the scheduled and the actual construction progress. Daily reports are also made of the status of all items which are delaying or will delay any construction progress operation.



The most compelling reason for a safety program is the welfare of the people who work in construction, and that of their families. If a company can't a ford Safety, it has no right to be in business.

It is essential to recognize construction's obligation to prevent accidents and the inherent hardships that follow. In a great many accidents there is damage to equipment and buildings, as well as to an employee. This not only creates a monetary loss of the equipment involved, but also a production loss which is so essential to the overall picture of a project of construction or industry.

At today's level of compet tion in the construction industry, it is most essential to be able to derive the utmost in efficient workmanship from the employee, and the best way to obtain this is through a Safety program that keeps the employee safe and the equipment that he uses in the best of condition, with no break-down caused by an unsafe condition.

In order to carry out such a Safety program, the Safety Engineer must be cost-conscious, and the best of cooperation from management will follow.

Housekeeping plays a very vital role in a Safety program and is one of the most difficult to administer. Supervision usually regards this subject as not a necessary need, but it is the most hazardous, due to fire which can cause more loss than any other.

The foregoing statements are but a few for the carrying out of a good Safety program, but we feel they are among the most essential.

A Safety record is the sum total of all activities that go to make up a Safety program, so let's all get Safety conscious and create a record that cannot
