Impressed with site spirit

Energy Secretary Watkins visits our enrichment plant

"You have a well-run plant. You obviously have a disciplined work force. Employees are highly sensitive to the importance of this facility. It's clean. People are serious about their work."

"I very much appreciate going into facilities and seeing how well they're managed."

Secretary of Energy Admiral James D. Watkins made these comments during a luncheon address during his visit to the Portsmouth Gaseous Diffusion Plant on Tuesday, May 29.

The purpose of Watkins' visit was to tour the plant and to meet with management and union leaders. He also addressed the work the Department of Energy will do over the next several years to select the site for the Atomic Vapor Laser Isotope Separation (AVLIS) plant.

"The AVLIS siting process will be very competitive," he said. Watkins noted that one of the siting processes will be Environmental Impact Statement hearings.

"I am impressed with the site, its cleanliness and its spirit," he said. "This is a unique installation in this country. All will

play into the Environmental Impact Statement hearings."

"But if you lose out on AVLIS, this plant is still going to be here for many years to come," he said. Watkins noted that at the beginning AVLIS would not necessarily supply all domestic and foreign enriched uranium requirements.

"I wish you well in this competition," he said. "There's nothing more important than to continue to do your jobs well."

Watkins went on to project that "the future of commercial nuclear power is solid if we make it solid. We must do our jobs right. We must build up our credibility with people."

He said the State of Ohio and the environmental protection agencies must continue to have open invitations to oversee the work at the Portsmouth site. "Come on in State. Come on in EPA. Take a look. If you find we're doing something wrong, we want to know about it."

He concluded his luncheon remarks by stressing the need for a full partnership between workers, Martin Marietta management and the Department of Energy.

Tom Young, President and Chief Operating Officer, Martin Marietta Corporation; Clyde Hopkins, President, Martin Marietta Energy Systems; and Ken Sommerfeld, Vice President, Enrichment, Martin Marietta Energy Systems, accompanied Admiral Watkins on his visit.

Upon their arrival, Gene Gillespie, Department of Energy (DOE) Site Manager, and Ralph Donnelly, Plant Manager, officially greeted the visitors and escorted them to a briefing session in the X-1000 Administration Building.

Arriving with Admiral Watkins were Ohio Senator John Glenn and Congressman Bob McEwen. Other visiting dignitaries included Polly Gault, Chief of Staff, DOE Headquarters; Ohio Senator Cooper Snyder; Richard Shank, Director, Ohio Environmental Protection Agency; Phil Sewell, Deputy Assistant Secretary for Uranium Enrichment; Joe La Grone, Manager, DOE Oak Ridge Operations (DOE-

Management contract extended

The U. S. Department of Energy (DOE) and Martin Marietta Energy Systems continue to negotiate a new five-year contract.

Energy Systems and DOE officials have signed four-month contract extensions. Both the Oak Ridge and Uranium Enrichment contracts now have been extended through Sept. 30.

This is the third extension. A six-month extension granted last fall expired March 31. The extension was then continued through May 31.

As negotiations continue on a new five-year contract, Chuck Landguth, Energy Systems vice president for administration, advises employees that progress is occurring and that "business as usual" continues.

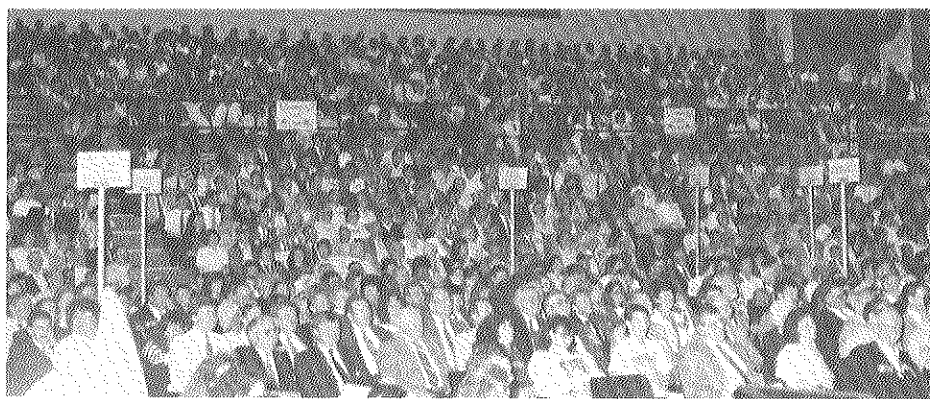

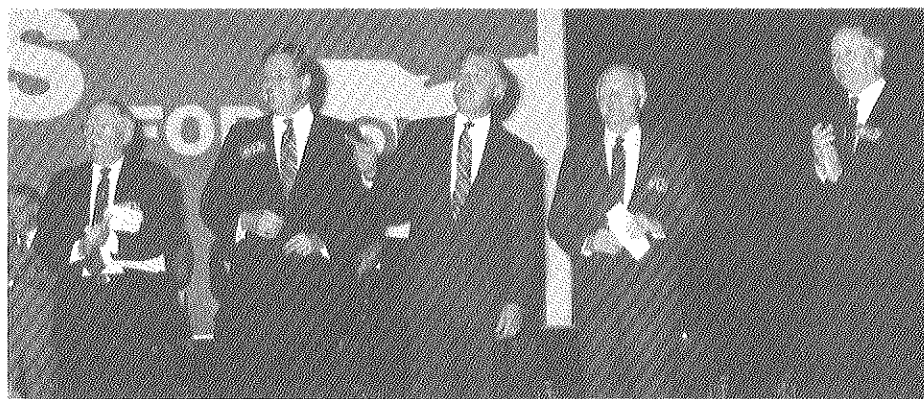

ORO); and Jim Hall, Assistant Manager for Enriching Operations, DOE-ORO.

Following the briefing, the group toured the plant. The first stop was the Special Nuclear Material Storage Facility. Dean Bussa, Uranium Material Handler, provided information on the sampling, storage and security procedures for high assay product enriched at the Portsmouth plant.

The X-333 Process Building was the

next stop. Buck Sheward, manager of the Environmental, Safety and Health Division, spoke on the polychlorinated biphenyls (PCB) containment system.

Next, the group toured the Gas Centrifuge Enrichment Plant (GCEP). Jim Morgan, Department Head, Project and Site Development and Integration, provided information on the GCEP process buildings and their uniqueness.

After departure from GCEP, the group

returned to the X-1000 Building for Admiral Watkins, Senator Glenn, Congressman McEwen, Polly Gault, Phil Sewell and Joe La Grone to meet with officials of OCAW Local 3-689 and UPGWA Local 66.

Later, at the luncheon in the X-1000 Building cafeteria, Admiral Watkins spoke to a group of employees. Before departing for Portsmouth, he conducted a brief news media conference.

Watkins pointed out to local news media the importance of the Portsmouth site, for the national security and for the future of energy throughout the world.

"Our concentration in these various site visits is on environmental, safety and health issues," he said.

"Environmental issues are being ad-

ressed internationally," Watkins said. He said the United States is "in a fish bowl" and its work is being looked at from around the world.

"We have a contractor here in Martin Marietta that understands these issues," he commented. "It's not at all hesitant to put into effect environmental, safety and health programs and changes."

The plant is a "cherished jewel and the crown of our national resources," Watkins told the news media. "We have to protect it and watch it. We're putting our action plans together" to address these issues.

"We are willing to accept reviews," he repeated for the reporters. "We're proud of our work. Anybody that finds anything wrong is doing us a favor."

Watkins concluded his press conference by saying he believes the plant is moving in the right direction. "It's a well-run plant. It's clean. Spirits are up. I'm proud to be here and a part of this."

Contract extended four months

"Although the negotiations have been lengthy, and several unresolved concerns have resulted in contract extensions, there are no obstacles we see that are insurmountable," said Landguth, a member of the company's negotiating team.

As examples of areas in which progress has occurred, Landguth cited "Appendix A" sections of both contracts which govern personnel requirements. "Those sections had to be totally updated. This has occurred, and the changes are in final review," he explained. "Numerous new contract clauses required because of new contracting formats also have been negotiated."

Another area of concern has been the issue of the company's signing various permits and other documents as facility to co-operator, along with DOE. (This type of document heretofore has been signed only by DOE as operator.)

"This change obviously involves some significant liability issues," Landguth said. "We have reached an agreement in principle on the basic clause, and this language is awaiting approval by the Martin Marietta Corporation board of directors. This language of an attachment defining who has responsibility for obtaining permits and for other steps in such a procedure also is in a final review process."

"This issue of contractor liability, as set forth in DOE rulemaking earlier this year,

is still the most significant public policy issue that DOE and its M&O contractors must address," Landguth said. "It currently is following the typical public policy schedule and format, with DOE officials awaiting responses to the document.

"It is likely that comments by the public and by contractor organizations may result in significant modifications to the current version of the policy. We are continuing negotiations on this particular issue, and we don't expect the situation to affect our business relationship with our customer in any way," he added.

"All parties are negotiating in good faith, and we expect to see additional progress and to continue our good working relationships at all levels with Department of Energy," Landguth said.

Martin Marietta Chairman and Chief Executive Officer Norman Augustine recently told company managers he is optimistic Energy Systems can remain as operating contractor for the five plants.

Augustine said that the issue of contractor liability "is a tough one. The corporation has an obligation to its shareholders and its employees to ensure that any liabilities and responsibilities that we take on are clearly defined and are proportional to the value of the benefits to be gained from the effort. I am also sympathetic to DOE's concerns, and I feel that good people with good ideas will prevail here, and that we will find our way through this maze."

Get out the bats, balls, and gloves!

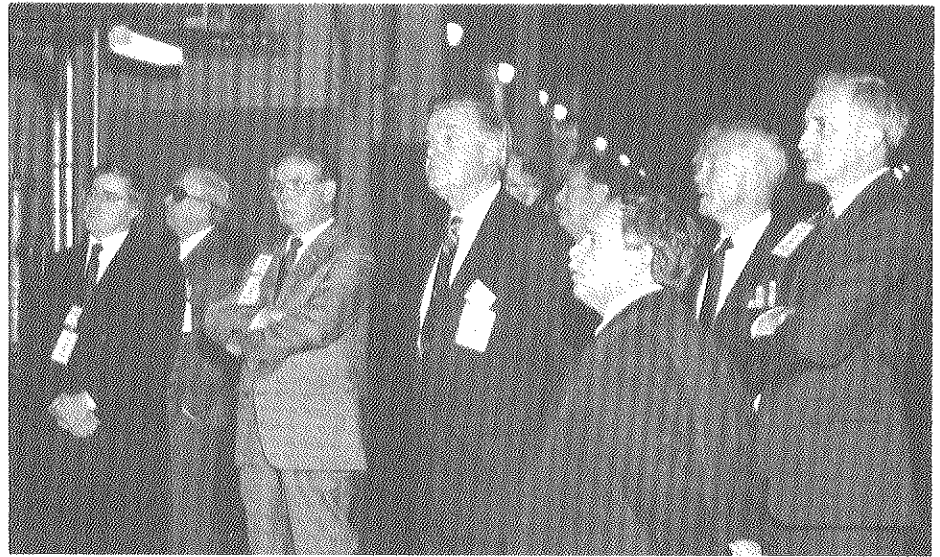
The 1990 Softball Tournament will be at Jake's Park in Waverly over the weekend of Aug. 25-26.

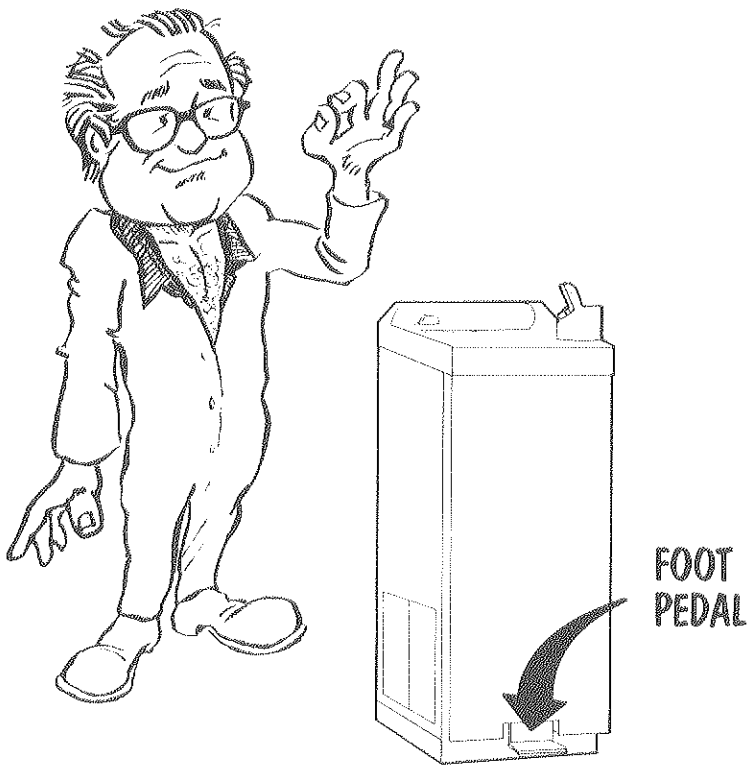

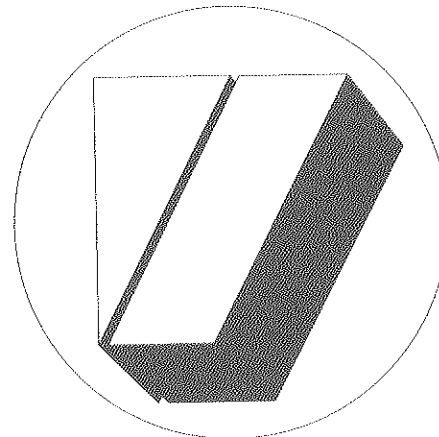
