#### Benefits

Employee contributions to the company's new Employee Savings Plan during the 12 months beginning July 1 and ending June 30, 1985, will earn interest at an effective annual rate of 14.75 percent. Contributions by employees made after June 30, 1985, will earn interest at a new rate to be negotiated prior to that date. Under the savings plan, employees contribute from 1 to 6 percent of pay, with the company also making contributions — equal to 25 cents on the dollar — in the form of Goodyear stock placed in a separate account. Federal and most state income taxes on these contributions and their earnings are deferred until funds are withdrawn. The next enrollment date is Oct. 1 for employees who elected not to participate for the July 1 start or who will become eligible to participate in the plan after that date. Applications must be submitted at least 30 days prior to the enrollment date.

Effective June 1, all GAT employees and retirees who are eligible for the Employee Tire Refund Program will be able to make tire and related service purchases and take up to six months to pay for those purchases. During that six-month period, no interest or finance charges of any kind will be applied to employee's account balances. The Silver Card Program is still available for those employees who wish to take longer than six months to pay for purchases. Normal interest rates are applied to account balances under the Silver Card Program. Credit-worthy eligible employees and retirees need provide proof that they are Goodyear employees or retirees in order to take advantage of this program. Purchases must be made at company-owned outlets and will apply to the purchase of new Goodyear tires and tire-related services (wheel balancing, valves and wheel alignment). Any purchase of less than \$30 must be made in one payment, and purchases of \$30 or more must be made in six equal monthly installments. The implementation of this new program will not affect the provisions and use of the current Employee Tire Refund Program. Further information will be available at each company-owned outlet. Employees wishing to utilize the interest-free program should be sure that they are dealing with a company-owned outlet prior to committing to any purchases.

#### News from DOE

Barry W. Krause has been named Chief of the Physical Safeguards Branch for DOE's Oak Ridge Operations. Krause, who joined the Department's Safeguards and Security Division in 1977 as

Assistant to the Chief of the Personnel Security Branch, subsequently was named Assistant Chief and then Chief of the branch. Beginning in July of last year, Krause also served as a member of a special task force that prepared a baseline assessment of the Strategic Petroleum Reserve (SPR), newly assigned to Oak Ridge Operations, and a subsequent report on a review of allegations involving the SPR activities.

Judith M. Penry is the new Chief of the Defense and Fossil Branch in the Office of Planning and Budget for DOE's Oak Ridge Operations. The branch Ms. Penry heads has budget responsibility for safeguards and security activities for all Oak Ridge Operations' sites and the weapons program and material production activities for the Y-12 plant, the Feed Materials Production Center near Cincinnati, and a uranium extrusion facility at Ashtabula. It also covers budget activities for fossil programs.

The Department of Energy (DOE) has announced the signing of a 30-year Utility Services Contract with the Tennessee Valley Authority (TVA) for providing TVA with enriched uranium to fuel the agency's nuclear power plants. The contract is the third one signed since DOE offered the new Utility Services Contract, featuring lowered cost and more flexible terms, to its domestic and foreign customers beginning in January of 1984. Duke Power Company was the first to sign in February and Detroit Edison Company signed a contract in May. Under these contracts, domestic and foreign utilities pay DOE for the service of enriching utility-owned uranium in the fissionable U-235 isotope, making the uranium suitable for conversion to fuel elements for nuclear power plants. The contract with TVA, DOE's third largest uranium enrichment customer, calls for DOE to provide TVA with approximately 26 million separative work units of enriching services through the year 2014, representing estimated revenues to DOE over that period of approximately \$3.5 billion at the current charge for enriching services. Under this contract DOE will provide TVA with 100 percent of its uranium enrichment requirements over the 30-year period; however, a major feature of the Utility Services Contract is the flexibility to permit TVA and other customers to vary their commitment from 70 to 100 percent of total requirements to best match their needs.
